

TAPESTRY OF NEW YORK
PARENTAL CONSENT FORM

Tapestry of New York, a project of THIRTEEN Productions LLC (“THIRTEEN”), is an online gallery of student artwork and media created in honor of America’s 250th anniversary. When a student submits their artwork to Tapestry of New York, the artwork is displayed in the online gallery at www.tapestryofny.org along with certain personal information about the student, including their first name and last initial (unless anonymity is requested), school/institution, school district, city/town, grade range and homeschooling status.

Certain federal and state laws protect the collection and disclosure of personal information about students and young children. In particular, the Family Educational Rights and Privacy Act (“FERPA”) and New York Education Law § 2-d protect the privacy of student education records and the Children’s Online Privacy Protection Act (“COPPA”) protects the collection, use and disclosure of personal information of children under the age of 13. In compliance with these laws, THIRTEEN requires parents or legal guardians to sign this Parental Consent Form before a student participates in Tapestry of New York. This Parental Consent Form is incorporated and made part of the Tapestry of New York Privacy Policy, available at <https://tapestryofny.org/privacy-policy/>, which provides additional detail about the collection, use and disclosure of personal information in connection with Tapestry of New York.
